Mr. Mario Montanero NJEA representative introduced himself and stated that he was representing Ms. Sonya Cramer. He read a prepared statement to the Board:

Dear Elk Township Board of Education members:

Please accept this written statement tonight via my NJEA UniServ Representative, Mario Montanero. While my preference was to appear before all of you personally during public session to apologize for something I communicated and to clarify what my intentions were in communicating it, UniServ has advised me to submit a written statement through my representative instead.

I have worked as a teacher for 23 years and for Elk Township Public Schools since [2001]. I love my job as a teacher. I love working with the children of this district. I have been proud to call this my professional home for the last 20 years. I have poured my heart and soul into this job. I have always done everything in my power to provide every single student in my classroom with the best, most supportive education possible and to teach with acceptance and inclusion.

I understand that a Facebook post I recently shared has caused upset in our community. For that, I am truly sorry. It was never my intention to cause pain or distress to anyone. Although I recognize that my intent does not and cannot change how that post was received, I want to take this opportunity to clarify that my only intention was to honor the life of a five-year old boy, who was roughly the same age as the students I teach, by sharing images of

him. It was not the first time that I have shared photos of children who are involved in tragedies because those stories touch my heart.

Unfortunately, in this instance I responded emotionally to the image without taking the time to read the context of the original post, which minimized the deaths of Black Americans, falsely claimed that the terrible tragedy involving this particular child received no media coverage, and used profane and offensive language. Over the last week, I have spent a lot of time reflecting on the power of words and images and decisions we make emotionally, and how this power is enhanced in an age of social media. In short, it was an awakening to my need to become an ally to the fight for racial equity.

I take full responsibility for sharing a post that I should have recognized as offensive. If I could undo my decision to repost it, I would.

Because I cannot undo that decision, what I can offer is a genuine apology from the bottom of my heart; a promise that the opinion attached to the image I shared, by the person who originally posted it—someone I do not know at all—does not reflect my core values as an educator, my personal beliefs, or the way I run my classroom. I personally commit to reaching out to anyone in the community who wants to express their concerns about the post, to listen to them, and to work with them to ensure that teachable moments regarding social justice will be available to others who need them.
